Workers who qualify for the CalEITC are also likely eligible for CalFresh food assistance and other public benefits. Dear [First Name or Friend],

Language should not create a further barrier to receiving the California Earned Income Tax Credit (CalEITC). That's why we'd like to remind everyone that our CalEITC calculator, a simple tool to determine your eligibility for the credit, is now available in several new languages.

Last year, our materials were available in Spanish, Mandarin, Vietnamese, Korean Tagalog, and Russian. This year we've added Hmong, Armenian and Farsi. Help us get the word out to those who could benefit!

To get the CalEITC, people have to file an income tax return. Some low-income workers, especially those only working part-time, may not be planning to file because their income level doesn't require that you do. Let them know that they could be leaving money on the table!

Please share this important news with your family, friends and loved ones. Make sure to let them know that they can still claim the credit even if they've already filed their taxes, and the CalEITC can be claimed throughout the year. But why wait?
