Xeev California tab tom txhawb cov pej xeev uas khwv tau nyiaj tsawg nrog them ib zaug \$600 rau cov neeg them se uas tsim nyog rau California Kev Them Se Rau COV Nyiaj Khwv Tau Los (CalEITC) thaum kev them se xyoo 2020. Txhawm rau tsim nyog rau Golden State Stimulus, koj yuav tsum:

- Khwv tau tsawg dua \$30,000 nyob rau xyoo 2020.**
Yog tias koj khwv tau qis dua \$30,000 nyob rau xyoo 2020, koj yuav tsim nyog rau Golden State Stimulus. Nco ntsoov los thov rau CalEITC lub caij them se no kom tsim nyog tau txais koj li nyiaj GSS.

- Ua ntawv them se nrog ITIN thiab koj khwv tau \$75,000 los sis tsawg dua hauv xyoo 2020.**
Yog koj ua koj cov ntawv se siv ITIN thiab koj khwv tau \$75,000 losis qis dua nyob rau xyoo 2020, tej zaum koj yuav tsim nyog tau txais \$600 them, txawm tias koj tsis tsim nyog rau CalEITC. Yog tias koj siv koj cov se uas siv ITIN thiab koj tsim nyog rau CalEITC thaum xyoo 2020, tej zaum koj yuav tsim nyog tau txais cov nyiaj them ib zaug ntawm \$ 1,200. Kawm paub ntau ntiv txog kev thov CalEITC ua ib tus tuav ITIN.
- Tau sau koj li ntawv se rau Lub Kaum Hlis Ntuj Tim 15, 2021**
If you earned income in 2020, and you qualify for the CalEITC, you must file your 2020 tax returns by October 15, 2021 to ensure you receive your GSS payment.
